### SIMEON PARK RULES

Simeon Park is committed to providing a safe and enjoyable environment for all Magna employees and their guests. All Magna employees and their guests must follow the park rules to ensure everyone can enjoy the park.

Please read and follow these rules carefully. Failure to do so may result in the immediate removal of the Magna employee and their guests from Simeon Park without recourse, suspension of the Magna employee's park privileges, and possible disciplinary action through the Magna employee's HR team, as appropriate.

#### Administration

- 1. The Magna employee sponsoring the event must be present for the entire duration of an event booking.
- 2. The Magna employee (not guests of the employee) should discuss concerns related to bookings, memberships, or programs with Simeon Park staff.
- 3. Simeon Park is not responsible for the loss, theft, damage, or destruction of personal property belonging to Magna employees and guests. Keep your vehicle doors locked and your personal property safe.
- 4. Fishing is permitted for those with an active fishing license (catch and release only).

### **Substance Use on Park Property**

- Alcohol may be consumed on premises in moderation by those of legal drinking age. The Magna employee sponsor will be responsible for ensuring their guests consume alcohol responsibly and do not operate any motor vehicles.
- 2. The Magna employee sponsor is responsible for the safe transport of their guests that consume alcohol on park premises.
- 3. Use of other impairing substances, including cannabis, are <u>not permitted</u> on park premises.

## Park Etiquette

- 1. Use of discriminatory, harassing, disruptive, abusive, or insulting language or behaviour is not permitted.
- 2. Please observe Simeon Park's operating hours prior to your arrival. There is no entry prior to opening times and all Magna employees and guests shall have their sites cleaned **10 minutes** before the park closes and exit the park by closing time.
- 3. Children must always be supervised. NOTE: The parking lot is <u>not</u> a place to play.
- 4. No pets are permitted in the park. Service animals are permitted but must be registered with Simeon Park staff prior to your booking and upon arrival on the day of your event.
- 5. Confetti, glitter, water balloons, or similar materials are not permitted. The park is on a conservation area.

- 6. Deposit all garbage and litter in the appropriate containers provided (garbage, recycling, and/or compost). If you require additional bags, please see a Simeon Park staff member.
- 7. Read and follow pool rules when using pool (located on pool deck).

## **Parking and Vehicles**

- 1. When parking your vehicle, park as close to the next vehicle as possible while leaving enough room for doors to open.
- 2. Do not park in "No Parking" areas.
- 3. Parking in front of the garage on the west side is not permitted.
- 4. Bikes, scooters, skateboards, sports, and playing in the parking and overflow lots is not permitted.
- 5. Please use overflow parking as directed by Simeon Park staff.
- 6. Do not drive vehicles to your picnic site.
- 7. Powered vehicles (i.e., scooters, ATVs, electric skateboards, etc.) are not permitted on Simeon Park property.

# **Safety and Noise**

- 1. Operation of an audio device (including but not limited to radio, stereo, TV, etc.) or a sound amplification device (e.g., bullhorns, whistles, etc.) is not permitted.
- 2. All broken glass must be immediately cleaned up and Simeon Park staff notified.
- 3. Coal BBQ must be put out with water. Do not dump any coal on the ground. Notify Simeon Park staff and they will dispose of the watered-down coal for you.
- 4. Use only charcoal BBQ starter. **Do not use gasoline or any other fuel**.
- 5. If security is required to respond to improper behaviour, the Magna employee sponsor will be charged for the cost of such service.
